Sergiu Constantin Enea is currently a doctoral student at the “Alexandru Ioan Cuza” University of Iasi. Principalities in the 19th century. He is a contributor and editor to international collections of articles and reviews, and author of several books

She completed a postgraduate course “Romanians and Europe (18th-19th centuries)” at the Faculty of History, “Alexandru Ioan Cuza” University of Iași, in 2006. She works as a Research Assistant at the Institute of History “A.D. Xenopol” in Iași, Department of Modern History. She is currently a doctoral student at the “Ștefan cel Mare” University of Suceava. Her research field is Modern history, especially History of Romanian Church.
